3. Unless expressly stated herein, all goods sold are covered by standard manufacturer's warranties.
4. Unless expressly stated herein, prices do not include installation, configuration or delivery charges, which are available on a fee for service basis.
5. Allneeds expressly disclaims all liability regarding the operation of software. Software warranties (if applicable) are provided only by the original publishers thereof.
6. This document (including description of goods) represents the entire contract between Allneeds and the purchaser. Unless expressly stated herein, all other representations and oral statements made by or on behalf of Allneeds do not form part of this contract, and may not be relied upon.
7. Allneeds shall be entitled to charge collection fee's and interest upon all outstanding amounts at the rate of 25% per annum calculated daily.
